Welcome and Opening Remarks: Carole welcomed everyone to the meeting.

#### Homeowner's Forum:

- Steve reported that he will try to contact a company to make a metal box to hold the information that will be posted on the street, sharing important information with the residents.
- Steve reported that our agent with Farmer's insurance, Victor Habib, is retiring. We will be notified when a new agent is assigned.
- Steve reported that some residents have inquired about the charging of electric
  cars. Members discussed that interested parties should install a charging station
  (which requires a permit from the City), and would have to have the electricity
  wired to their home. Steve will investigate to get all the required steps for
  implementation.

#### Update on HH2 Meeting:

 Ann reported on a meeting held by the HH2 Board about installing security cameras within phase 2, since there have been several home invasions. They have selected to have 4 Flock cameras. These cameras are installed and maintained by the company, and cost ~\$2000 per year/per camera. The cost includes installation, maintenance, cloud storage, cellular service, and software updates. The members felt that HH1 Association should consider at least 1 or 2 cameras, and will discuss further with members.

Commenting on Election Rules, which was circulated to HOA owners:

- Carole will give Ann an updated survey, and Ann will get copies made. Ann and Steve will work to mail the updated survey to non-resident owners, and provide it to all resident owners in the next couple of weeks.
